

**OFFICE MEMORANDUM**

Subject:- Board level posts and below Board level posts including non-unionised supervisors in Central Public Sector Enterprises- Revision of scales of pay w.e.f. 01.01.1997 – Payment of IDA at revised rates regarding.

In continuation of this Department's O.M. of even number dated 14.07.2008, the rate of DA payable to the executives of CPSEs may be modified as follows:


<u>Effective Date</u>	<u>Average of AICPI</u>	<u>Revised DA rates (%)</u>
01.10.2008	3256	90.6

These rates may be made applicable in the case of IDA employees, whose pay have been revised with effect from 01.01.1997 as per DPE O.M. dated 25.06.1999 on the following lines:

- a) In case of CPSEs who have not allowed the benefit of merger of 50% of DA with basic pay as contained in DPE O.M. dated 26.02.2008 to their employees, the DA payable may be enhanced from the existing rate of 84.4% to 90.6% with effect from 01.10.2008.
- b) In case of CPSEs who have allowed the benefit of merger of 50% of DA with basic pay as contained in DPE O.M. dated 26.02.2008 to their employees, the DA payable may be enhanced from the existing rate of 34.4% to 40.6% with effect from 01.10.2008.

All administrative Ministries/ Departments of the Government of India are requested to bring the foregoing to the notice of the Public Enterprises under their administrative control for action at their end.


